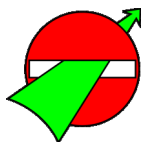

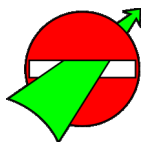

According to the issue # 13 of Law Decree 06/30/2003 #196, referring to the common data meant to be treated, we provide the following information:

**1) Contents of the data**

Contents of the data treated about personal data of the attenders and collaborators of the festival 'Contrometraggi'.

**2) Purposes and modes of the treatment**

Pupuses and modes of the tratment to which the data will be used, data that will be acquired and updated. It has the following purposes:

- purposes connected to organize the festival;
